# ABOUT THE WILLIAM T. TURMAN SWOPE PLEIN AIR COMPETITION AND EXHIBITION

The 2025 Swope Art Museum William T. Turman Plein Air competition is open to all painters. All works must be painted during the event period, June 20 - 25, and must be created in Terre Haute and Vigo County, Indiana.

This outdoor painting event is a tribute to William Turman, a preeminent plein air painter from Graysville, Indiana. Turman was the second director of the Swope Art Museum, and Chairman of the Indiana State University Art Department for 40 years. Turman was part of the rich history of Indiana landscape painters including T.C. Steele, William Merritt Chase, and William Forsyth.

## **HOW TO ENTER**

Qualified entries are eligible for up to \$5000 in purchase and cash prizes. Swope members at the \$125 sustaining level or above are entitled to free entry in the competition. Non-members pay \$40. Online and mailed entries must be received by June  $17^{th}$ . Walk-in registration at Arts Illiana, 23 North  $6^{th}$  Street, June 18-20, during open hours, Tuesday - Saturday 10~AM-4~PM. The Swope is partnering again this year with Arts Illiana. Because of renovations at the Swope Art Museum, all walk-in registration will take place at Arts Illiana. All painting supports must be stamped to be eligible for awards. Bring blank supports to Arts Illiana, 23 North 6<sup>th</sup> Street to be stamped.

All paintings must be submitted by NOON on June 25 at the Arts Illiana Gallery, 23 North 6<sup>th</sup> Street, Terre Haute, Indiana. Only stamped paintings will be accepted. All works must be display-ready with a wire on the back. Frames are optional, but keep in mind that artworks will be handled for installation purposes. The Swope Art Museum and Arts Illiana are not liable for any damage to artwork. Only traditional painting mediums are accepted: oil, acrylic, pastel, and watercolor.

## **JUROR**

Julio Suarez received his MFA in Painting from Indiana University Bloomington and a BFA in Illustration from the School of Visual Arts in

New York City where he first discovered his passion for painting and drawing from direct observation. His influences range from old masters such as Velasquez and Vermeer to 20th century artists like Giorgio Morandi and the English painter Euan Uglow. Suarez's work has been exhibited nationally including at the Painting Center and Blue Mountain Gallery in New York City and Principle Gallery in Alexandria Virginia. He recently received a Best of Show award at the 56th Annual Greater Michigan Art Exhibition organized by the Alden B. Dow Museum of Science and Art.

#### **Artist's Statement**

My work is about perception, attention and looking for beauty in the mundane. Using direct observation, I paint the people and objects that surround me. I believe that only through drawing or painting something can I really see it and understand it. I enjoy both the process of discovering what makes something look the way it does and the struggle to translate that into paint in the simplest way possible. The interaction with the subject and trying to capture the many moments of attention placed on it, is what keeps me most engaged in a painting and why working directly from the motif is central to my work.

- This call is for all painters working in 2D media, limited to oil media (traditional and water-mixable), wet media (acrylic, watercolor, and gouache), and dry media (pastel).
- A \$40 non-refundable entry fee is due upon registration. Registration for the competition is included in the \$125 Sustaining level Swope membership or above. Go to <a href="https://www.swope.org/pleinair">www.swope.org/pleinair</a> to access the link to membership and to review the many benefits, including five free entries in the Wabash Valley Exhibition!
- Painting supports must be blank or a toned ground to be eligible for registration, exhibition, and awards.
- Paintings must be completed in Terre Haute or Vigo Country and must be painted at least 80% *en plein air.*
- Paintings may be offered for sale to the public at the conclusion of the jury process. Sold artwork will remain on display until the end of the exhibition. All submitted paintings will be on display at the Arts Illiana Gallery at 23 North 6<sup>th</sup> Street in Terre Haute, Indiana from July 1 August 15, 2025. Arts Illiana and the Swope Art Museum share 30% commission on sales.

All supports must be stamped and registered to be eligible for exhibition and awards!
